



**BAC RESOLUTION DECLARING BODEGA ENTERPRISES AS THE BIDDER WITH THE LOWEST CALCULATED AND RESPONSIVE BID (LCRQ) FOR THE CONTRACT: PURCHASE OF 40 PIECES ERGONOMIC CHAIRS FOR USE AT THE BU UNIVERSITY LIBRARY**  
*Resolution No. LCRQ-060-25-AMP*

WHEREAS, the BICOL UNIVERSITY requested for the project **Purchase of 40 pieces Ergonomic Chairs for use at the BU University Library** with an Approved Budget for the Contract (ABC) of **One Hundred Thousand and 00/100 Pesos (Ph100,000.00)**;

WHEREAS, the BAC resorted to Negotiated Procurement under SVP (Section 53.9) as an alternative mode and posted the project in the GEPS website, agency BAC Bulletin Board for the period April 25 to 30, 2025;

WHEREAS, the committee waived the formalities of competitive bidding procedures and issued Request for Quotations from suppliers of known qualifications;

WHEREAS, seven (7) suppliers were provided with quotation forms namely, **SITIO CALDO MPC, BODEGA GLASSWARE, BODEGA ENTERPRISES, MAGIC 24 MKTG, BENGX PRINT GRAPHIC & ARCHITECTURAL SERVICES, ACES HARDWARE PHIL. INC., JEDI & JOSHUA OFFICE SUPPLIES TRADING**, and four (4) bidders submitted the quotation with results as follows;

- j) To recommend for approval by VP for Academic Affairs the foregoing findings.


