**BICOL UNIVERSITY**, a state university created and existing by virtue of Republic Act NO. 5521 as amended, with principal address at Rizal St., Legazpi City, represented in this instance by its President, DR. BABY BOY BENJAMIN D. NEBRES III, being the Head of the Procuring Entity, and is hereinafter referred to as the "PROCURING ENTITY";

**JOINT VENTURE: CENTURION DIGITAL INFRASTRUCTURE AND DEVELOPMENT CORP. And REMAX INTERNATIONAL INC.**, an entity created and existing by virtue of the Laws of the Republic of the Philippines, with business address at Suite 3219, High Street South Corporate Plaza, Tower 2 26 St., Fort Bonifacio, Taguig City, Fourth District, NCR, and #18 United St., Kapitolyo, Pasig City Respectively, represented in this instance by its representative, Mr. JAMES H. DE MESA and is hereinafter referred to as the "SUPPLIER".

**WHEREAS**, the ENTITY Invited Bids for certain goods and ancillary services, particularly *SMART CAMPUS ADVANCE CYBERSECURITY PLATFORM* and has accepted by the Supplier for the supply of those goods and services in the sum of Eight Hundred Forty Eight Million Forty Six Thousand Seven Hundred Pesos (*Php848,046,700.00*).

NOW THIS AGREEMENT WITHNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - a. Schedule of Requirements;
    - b. Technical Specifications;
    - c. General and Special Conditions of Contract; and
    - d. Supplemental or Bid Bulletins, if any.
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - iii. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iv. Performance Security;
  - v. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - vi. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.



3. In consideration of the sum of Eight Hundred Forty Eight Million Forty Six Thousand Seven Hundred Pesos (848,046,700.00) **JOINT VENTURE: CENTURION DIGITAL INFRASTRUCTURE AND DEVELOPMENT CORP. And REMAX INTERNATIONAL INC.,** agrees to provide **SMART CAMPUS ADVANCE CYBERSECURITY PLATFORM** in accordance with its Bid.
4. The **BICOL UNIVERSITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


